Notice

Order to Return Borrowed Items to the University Library of the Technical University of Munich (TUM)

This translation is provided for your convenience only. The original German letter you received by postal mail is the sole legally binding version. Please refer to the original letter for all details regarding due dates, fees, and billing reference.

Dear Sir or Madam,

The University Library of the Technical University of Munich (TUM) hereby issues the following notice:

1. The return of the borrowed item(s) to the TUM University Library is ordered pursuant to § 18 para. 5 sentence 1 of the General Regulations on the Use of Bavarian State Libraries (Allgemeine Benützungsbildung der Bayerischen Staatlichen Bibliotheken, ABOB). You are required to return the item(s) listed in the annex to the original letter sent to you by postal mail within one week from the date of this letter.
2. You are excluded from using the TUM University Library for a period of six months.
3. Immediate enforcement of items 1 and 2 is hereby ordered.

If you fail to fulfill your obligation to return the respective item(s) **within one week from the date of the original letter** sent to you by postal mail, the TUM University Library will, pursuant to § 18 para. 6 ABOB, consider the item(s) lost and demand compensation by means of an administrative enforcement order in accordance with § 8 para. 3 ABOB.

Reasons

The TUM University Library, as an authority of the Free State of Bavaria, is substantively and locally competent to order the return of items borrowed from its collections, pursuant to Art. 1 para. 2 sentence 1 no. 1 alt. 9, Art. 29 para. 5 sentence 2 half-sentence 1, and Art. 4 para. 2 sentence 2 of the Bavarian Higher Education Innovation Act (Bayerisches Hochschulinnovationsgesetz, BayHIG), Art. 3 para. 1 no. 4 of the Bavarian Administrative Procedure Act (Bayerisches Verwaltungsverfahrensgesetz, BayVwVfG), and § 1 para. 1 ABOB.

You borrowed item(s) from the TUM University Library, which are listed in the annex to the original letter sent to you by postal mail. The loan period for the item(s) has expired. After the due dates, the TUM University Library repeatedly requested, pursuant to § 18 paras. 3 and 4 ABOB, that you return the item(s), so far without success. Most recently, the third return request was delivered to you by registered mail.

Despite these repeated requests, you have not yet returned the borrowed item(s) to the TUM University Library. Pursuant to § 18 para. 5 sentence 1 ABOB, the return must therefore be ordered by means of an administrative notice, subject to charges. Since your refusal to return the borrowed item(s) constitutes a repeated and serious violation of both the ABOB and the orders of the TUM University Library, the previously threatened suspension of your user privileges for a period of six months must be imposed. The order for immediate enforcement is based on § 80 para. 2 no. 4 of the Administrative Court Ordinance (Verwaltungsgerichtsordnung, VwGO) and § 18 para. 5 sentence 1 ABOB.

The special public interest required for immediate enforcement is given, as failure to return borrowed items after the end of the loan period, despite repeated requests, seriously jeopardizes the proper operation of the library. Accordingly, the exclusion from use of the library must also take effect immediately, pursuant to § 26 para. 1 sentence 1 ABOB.

The decision on costs is based on § 12 para. 5 ABOB in conjunction with Art. 1 para. 1 sentence 1, Art. 2 para. 1 sentence 1, Art. 5 para. 1 sentence 2 no. 4, Art. 6 para. 1 sentence 1, and Art. 10 para. 1 no. 2 of the Bavarian Costs Law (Kostengesetz, KG) in conjunction with tariff no. 3.III.2/9 of the Bavarian Schedule of Costs (Kostenverzeichnis, KVz).

Under German federal law, a procedural fee is incurred in proceedings before administrative courts as a result of the filing of an action.
